"Sign Up or Fill Up" Contest OFFICIAL CONTEST RULES AND REGULATIONS

("Official Rules")

Open to all residents of Canada (excluding residents of the Province of Québec)

1. NO PURCHASE NECESSARY: The United Farmers of Alberta Co-operative Limited "Sign Up or Fill Up" Contest (the "**Contest**") is sponsored by United Farmers of Alberta Co-operative Limited ("**UFA**" or the "**Sponsor**"). The Contest starts at 12:01 AM Central Standard Time ("**CST**") on September 29, 2025 and closes at 11:59 PM CST on October 17, 2025 (the "**Contest Period**").

2. ELIGIBILITY: To enter and be eligible to win, a person must: (1) be a legal resident of Canada (excluding residents of the Province of Québec); (2) have reached the age of majority at the time of entry in the Province or Territory in which they reside; (3) not be an employee of the Sponsor, its affiliated companies or agents, their respective advertising or promotional agencies or the independent contest organization; (5) not be at any time of entry, an elected official, employee, petroleum agent or employee of a petroleum agent of/for the Sponsor, its subsidiaries, divisions, affiliates, associates, licensees, dealers, or service agencies; and (6) not be any member of any such person's immediate family (regardless of where they live) or persons with whom they are domiciled (whether related to the employee or not). In these Official Rules, "**immediate family**" includes mother, father, brothers, sisters, sons, daughters, partner and/or spouse.

3. HOW TO ENTER THE CONTEST: There are three (3) ways to enter the Contest.

Fill Up: During the Contest Period, any UFA customer who purchases at least thirty litres 30 L of fuel per fill at the Regina UFA Petroleum Agency and Cardlock or receives a bulk delivery from UFA ("**Product**") will be automatically entered into the Contest. Entries must be received by 11:59 PM CST on October 17, 2025 (the "**Contest Closing Date**"). For every Product purchased during the Contest Period, you will receive one (1) entry.

Sign Up: During the Contest Period, sign up for a UFA Fuel Link Card or UFA Cardlock Card via <https://ufa.com/ca/petroleum/fuel/get-your-card> and be automatically entered into the Contest upon successful completion of sign up process. Entries must be received by the Contest Closing Date.

Without Purchase: During the Contest Period, on a plain piece of paper, hand print your full name, complete mailing address (including postal code), daytime telephone number (including area code), a valid email address, your preferred participating UFA location, and mail with sufficient postage to: "UFA Sign Up or Fill Up" Contest c/o Marketing Communications, United Farmers of Alberta Co-operative Limited, Suite 700, 4838 Richard Road S.W., Calgary, Alberta, T3E 6L1. All entries must be received on or before the Contest Closing Date. There are no limits to the number of entries a person may submit by mail-in, but **there is a limit of one (1) mail-in entry per mail piece.**

4. PRIZES: There will be one (1) prize available to be won (the “**Prize**”), consisting of a \$500.00 Dollar (CDN) UFA Gift Card. The approximate retail value of the Prize is Five Hundred (\$500.00) Dollars (CDN).

All other costs not specifically stated herein as being included with the Prize shall be the responsibility of any Prize recipients. Changes may occur in some of the specifications, features, optional equipment and pricing of the Prizes. The Sponsor reserves the right to make such changes, if so required. The Prize must be accepted as awarded without substitution, is not transferable, not for resale and has no cash surrender value. The Sponsor reserves the right, in the event that the Prize or any component of the Prize cannot be awarded as described for any reason, to substitute another Prize or component of a Prize of equal or greater value, without liability. In the event that a Prize recipient does not use or accept any portion of the Prize, there will be no extension, transfer, substitution or any kind of compensation provided.

5. PRIZE DRAW: A random draw will be held for the Prize on October 24, 2025 at approximately 10:00 AM CT (the “**Draw Date**”) in Calgary, Alberta from among all eligible entries received by the Contest Closing Date. Odds of being selected depend on the total number of eligible entries received by the Contest Closing Date. The selected Prize recipient will be contacted by mail, telephone or email within ten (10) business days of the Draw Date. If the selected Prize recipient (a) cannot be reached by mail, telephone or email within ten (10) business days of the Draw Date; (b) fails to correctly answer the skill testing question(see Rule 6); or (c) fails to return the properly executed release form, as provided by UFA, within the specified time (see Rule 6), then they will be disqualified and another Prize recipient will be randomly selected until such time as contact is made by mail, telephone or email with a selected Prize recipient or there are no more eligible entries, whichever comes first.
