United Farmers of Alberta Co-operative Limited "Peace Country Classic Tradeshow" Contest OFFICIAL CONTEST RULES AND REGULATIONS ("Official Rules")

Open to all residents of Canada (excluding residents of the Province of Québec)

- 1. NO PURCHASE NECESSARY: The United Farmers of Alberta Co-operative Limited "Peace Country Classic Tradeshow" Contest (the "Contest") is sponsored by United Farmers of Alberta Co-operative Limited ("UFA" or the "Sponsor"). The Contest starts at 10:00 AM Mountain Time ("MT") on March 6, 2025 and closes at 8:00 AM MT on March 21, 2025 (the "Contest Period").
- **2. ELIGIBILITY:** To enter and be eligible to win, a person must: (1) be a legal resident of Canada (excluding residents of the Province of Québec); (2) have reached the age of majority at the time of entry in the Province or Territory in which they reside; (3) not be an employee of the Sponsor, its affiliated companies or agents, their respective advertising or promotional agencies or the independent contest organization; (4) not be at any time of entry, an elected official, employee, petroleum agent or employee of a petroleum agent of/for the Sponsor, its subsidiaries, divisions, affiliates, associates, licensees, dealers, or service agencies; and (5) not be any member of any such person's immediate family (regardless of where they live) or persons with whom they are domiciled (whether related to the employee or not). In these Official Rules, "**immediate family**" includes mother, father, brothers, sisters, sons, daughters, partner and/or spouse. (6) For the Canterra Seed prizes the winner must have a **Legal Land Description (LLD)**.

3. HOW TO ENTER THE CONTEST: There are two (2) ways to enter the Contest.

Without Purchase at Event: During the Contest Period, complete the electronic ballot and submit at the UFA booth at the Peace Country Classic Tradeshow, located at Evergreen Park, Grande Prairie, Alberta from March 6 – 8, 2025. All contest ballots can only be obtained in person at the UFA booth at Peace Country Classic. Only one (1) electronic ballot may be submitted per person, per day. As a result, an individual can have a maximum of three (3) electronic ballots entered into the contest if they attend in person and submit an electronic ballot each day of the Peace Country Classic Tradeshow. Entries must be received by 4:29 PM MT on March 8, 2025.

Without Purchase: During the Contest Period, on a plain piece of paper, hand print your full name, complete mailing address (including postal code), daytime telephone number (including area code) and/or a valid email address, and your preferred participating UFA location and your UFA member account number, and mail with sufficient postage to: "UFA **Peace Country Classic Tradeshow**" Contest c/o Marketing Communications, United Farmers of Alberta Co-operative Limited, Suite 700, 4838 Richard Road S.W., Calgary, Alberta, T3E 6L1. All entries must be received on or before 8:00 AM MT on March 21, 2025 (the "**Contest Closing Date**"). There are

no limits to the number of entries a person may submit, but there is a limit of one (1) mail-in entry per mail piece.

4. PRIZES: There will be three (3) prizes available to be won (each a "**Prize**"), one prize consisting of a \$250.00 UFA Gift Card, with an approximate retail value of two hundred and fifty (\$250.00) dollars (CDN) and two prizes consisting of a bag of Canterra CS3300TFHSFBS canola seed with an approximate retail value of one thousand and eight (\$1,008.00) dollars (CDN) each.

All other costs not specifically stated herein as being included with the Prize shall be the responsibility of any Prize recipients. Changes may occur in some of the specifications, features, optional equipment and pricing of the Prizes. The manufacturer and Sponsor reserve the right to make such changes, if so required. The Prize must be accepted as awarded without substitution, is not transferable, not for resale and has no cash surrender value. The Sponsor reserves the right, in the event that the Prize or any component of the Prize cannot be awarded as described for any reason, to substitute another Prize or component of a Prize of equal or greater value, without liability. In the event that a Prize recipient does not use or accept any portion of the Prize, there will be no extension, transfer, substitution or any kind of compensation provided.

- **5. PRIZE DRAW:** A random draw will be held for each Prize on March 21, 2025 at approximately 1:00 PM MT (the "**Draw Date**") in Calgary, Alberta from among all eligible entries received by the Contest Closing Date. Odds of being selected depend on the total number of eligible entries received by the Contest Closing Date. The selected Prize recipient(s) will be contacted by mail, telephone or email within ten (10) business days of the Draw Date. If a selected Prize recipient (a) cannot be reached by mail, telephone or email within ten (10) business days of the Draw Date; (b) fails to correctly answer the skill testing question (see Rule 6); or (c) fails to return the properly executed Release Form, as provided by UFA, within the specified time (see Rule 6), then they will be disqualified and another Prize recipient will be randomly selected until such time as contact is made by mail, telephone or email with a selected Prize recipient or there are no more eligible entries, whichever comes first. The Sponsor will not be responsible for failed attempts to contact a selected Prize recipient.
- **6.** To be declared a winner, a selected Prize recipient must answer correctly, without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question posed by mail, telephone or email. The selected Prize recipient will also be required to sign a declaration and release form, as supplied by UFA, (the "**Release Form**") confirming compliance with the Official Rules, acceptance of the Prize as awarded, without substitution, and releasing the Sponsor, its affiliated and related companies, advertising and promotional agencies, the independent contest organization, and their respective shareholders, directors, officers, employees, agents, representatives, successors and assigns from any liability in connection with the Prize or the Contest. The Sponsor will make the Prize available to the Prize recipient as either detailed by the Sponsor or at the UFA store closest to the Prize recipient's place of residence within ten (10) days of being declared the Prize recipient. It is the responsibility of the Prize recipient to pick up the Prize within fifteen (15) days of being notified of its availability, failing which the Prize is forfeited. The Prize will not be released unless the Prize recipient first shows proof of eligibility.

7. GENERAL

By entering the Contest, entrants agree to abide by the Official Rules and the decisions of the Sponsor, judges and independent contest organization with respect to all aspects of the Contest, which are final.

The Sponsor and the independent contest organization accept no responsibility for loss, damage or claims caused by or resulting from the Contest or the Prize associated with this Contest. By entering and accepting the Prize, the Prize recipient consents to the use of their name, address (location, hometown, city and province) and/or photograph, without further remuneration, in connection with any publicity carried out by or on behalf of the Sponsor with respect to this Contest and in advertisements for subsequent contests.

The Sponsor and the independent contest organization will not be responsible for late, lost, illegible, incomplete or destroyed entries; all such entries are void. The Sponsor and the independent contest organization do not assume any responsibility for lost or delayed mail-in entries, incorrect or inaccurate capture of entry information, technical malfunctions, human or technical error, printing errors, lost, delayed or garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer lines or networks or internet, computer equipment, software or any combination thereof. Entry material/data that have been tampered with or altered are void. In the event it is determined that an entrant has entered in a fashion not sanctioned by the Official Rules, the entrant will be disqualified and all of the entries submitted by the entrant will be disqualified.

All entries become the permanent property of the Sponsor and none will be returned. All entries and related intellectual property rights, including but not limited to copyright, become the sole property of the Sponsor, without compensation to entrant. Upon entry each entrant irrevocably waives all moral rights protecting the entry. Entries, may, throughout the Contest and thereafter, be distributed, used, reproduced, exhibited, donated, sold and/or displayed by the Sponsor on their website or in a UFA location, which rights are granted by an entrant to the Sponsor upon entry, all without notice or compensation to entrant. No correspondence will be entered into except with the potential Prize recipient after the Contest Closing Date. This Contest is subject to all applicable Federal, Provincial and municipal laws. Entries must not violate, misuse, misappropriate or infringe the intellectual property rights or any other property or rights of any other person or entity.

- **8. TERMINATION OF CONTEST:** The Sponsor reserves the right to terminate or amend this Contest at any time and in any way, without prior notice. Without limiting the foregoing, if, for any reason, the Contest is not capable of running as originally planned, the Sponsor reserves the right to cancel the Contest and conduct a draw from all previously received eligible entries received by the Contest Closing Date. The Sponsor and the independent contest organization shall not be held responsible for any problems, errors or negligence that may arise or occur in connection with the Contest.
- **9. PRIVACY:** The Sponsor respects your right to privacy.
