

INSTRUCTIONS FOR ADDITIONAL SIGNING OFFICERS AND FOR CO-BORROWERS WHERE BORROWER IS A PARTNERSHIP OR CORPORATION

- A. If the Borrower is a partnership, each of the partners (100%) must complete and sign the Ownership Profile.
- B. If the Borrower is a corporation, each of the shareholders who together own a minimum of 25% of the voting shares of the corporation must complete the Ownership Profile, and shareholder(s) who own(s) 51% or more of the voting shares must sign the Ownership Profile.
